## About This School

### **School Description and Mission Statement**

#### Philosophy

The Sanchez community is dedicated to the formation of students who are analytical, curious and happy, through a wide range of experiences and learning guided by high expectations, student success and equal opportunity for students and their families.

#### Description

Sanchez College Preparatory is one of the 67 elementary school sites that is a part of San Francisco Unified School District. We have a diverse population with 80% Latino, 5% African American, 3% American Indian, 2% Filipino, 2% Caucasian and 8% Other. 65% of our children are English Language Learners and 82% are eligible for free or reduced lunches. We serve families from 16 zip codes throughout San Francisco.

#### Classrooms

Two Reggio Emilia inspired preschool classrooms serve a total of 40 children.

Six School Age bilingual English/Spanish classrooms serve 113 students ranging from Kindergarten to 5th grade that makes up the Biliteracy Pathway. Our educational goal is to have all students exiting from Sanchez proficient in English and Spanish at the fifth grade level in all subject areas.

Six School Age classrooms serve 115 students ranging from Kindergarten to 5th grade that comprises the English Language Development Pathway. Our educational goal is to have all students exiting from Sanchez proficient in English at the fifth grade level in all subject areas.

Four Special Day Classrooms serve 42 students with special rights and needs. There are two classrooms that serve students in kinder through second grades and two classrooms serving students in third through fifth grades.

Four ateliers provide all students opportunities to explore different languages of learning through visual arts, technology, dance/movement and drama/music.

#### Schedule and Hours

The Sanchez College Preparatory School is open Monday through Friday from 7:30 am to 6:00 pm. The program for school-age children operates an after school program following the elementary school calendar.

### **RECOGNIZING THE VALUE OF THE THREE PROTAGONISTS: THE CHILD, TEACHER AND PARENT WHILE INVESTIGATING THE MANY LANGUAGES OF LEARNING**

Our central value is to develop strong leadership with each of the three protagonists in this educational system. Initiatives have been specifically designed to build leadership through personal and social responsibility amongst the three protagonists. Children have rich opportunities to explore many languages of learning every week through classroom-based experiences. These learning experiences are enriched through children's involvement in four ateliers that engage students in visual arts, technology, dance/movement and drama/music. Students' leadership is developed through student council, cross-age buddy reading and serving as junior coaches for younger students.

Teacher leadership has been supported by teacher leaders at each grade level facilitating Results Orientated Cycle of Inquiry on a weekly basis. Prior to the launch of these grade level investigations a Retreat is held with the Leadership Team to plan the structure for the school year. Three instructional cycles provide rich opportunities of research to assess how instruction is supporting students' learning towards grade level standards. This process helps to support teachers to become

more effective researchers of their own practice. The School Site Council is another area where teacher leadership has been fostered to ensure that funding allocations support the school’s vision and to monitor the ongoing implementation of the Sanchez Balanced Scorecard.

Parent leadership has become stronger through collaboration with the San Francisco Organizing Project. A range of leadership development strategies have been employed, including an overnight retreat at the Marin Headlands Institute that has been supported with funding through the Zellerbach Family Foundation. The Parent Liaison has emphasized a parent-to-parent leadership development. Parent leadership is manifesting itself on the School Site Council, English Learner Advisory Council and PTA. Every classroom has an active parent support team with parents serving as co-captains.

This schoolwide emphasis on this value of the three protagonists is producing positive student outcomes in the form of improved school attendance and increased student learning through formative/summative assessments.

All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

### ***For Elementary and Middle Schools (grades K-8)***

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 9, 2018 meeting of the Board of Education.
